Maquera holds a B.A. from the University of Pennsylvania and an M.B.A. from Harvard.

Steve Kelley is a security software veteran with over 15 years of experience in technology strategy, product management, and business development roles in the enterprise information technology industry. His prior experience includes working at BeyondTrust as EVP, Corporate Development where he helped drive the firm's product and M&A strategy to reposition the company as the global leader of Privileged Identity Management solutions across physical, virtual and cloud-based data centers. Prior to BeyondTrust, Kelley worked at Websense in product management and business development leadership roles that contributed to the company's market leading position in the secure content management market, as the company grew from \$35 million in revenue to over \$300 million in total billings over a seven year period. He was also

a co-founder at Taasera, Inc., a next generation security software company that was focused on establishing trustworthiness of enterprise technology assets in cloud infrastructures. Kelley began his career at Andersen Consulting (now Accenture) and he has a B.B.A. from the University of Notre Dame and an M.B.A. from the Kellogg School of Management at Northwestern University.
